## **Professional Background:**

I am the Chief Technology Officer for the Wake County Public School System. I served three other NC Districts of various sizes in the past as 21st Century Learning Coordinator, Lead Teacher for Technology (K-5) and Media (K-12); Lead Teacher for Math, Science, Social Studies and Technology (K-5); district and school Technology Facilitator; and Kindergarten and First Grade teacher. I serve on K12 Education Advisory Boards for the RTM K-12 Congress, Lenovo and IMS Global. I am on the Board of Directors for CoSN (Consortium of School Networking) and serve on the Executive Board as Secretary. I am a founding member and board member of the NC CoSN (Consortium of School Networking) chapter and a CoSN CETL (Certified Educational Technology Leader).

## What are the two most important priorities for CoSN to focus on in the next three years?

Diversity, Equity and Inclusion - Though CoSN has begun work around diversity, equity, and inclusion, there is so much to be done. CoSN members need to understand their own biases through learning and reflection in order to better lead in their districts, departments, and beyond. The CoSN Diversity, Equity and Inclusion committee is already working on resources for the membership; however, it will be in the use of those resources that we will see greater change in people, places, and teams. CoSN should give our members safe space to learn, process, reflect, and grow. We can do this through courses, cohorts of learners, coaching, and more.

Data Privacy and Cybersecurity - The pandemic brought two related topics to the forefront for technology leaders: the adoption cycle for digital resources (data privacy) and cybersecurity risks. More now than before, teachers and leaders look for low-cost or free resources to help learning and business core functions. There is often a tension between what is instructionally sound versus what is safe and secure for student use. While adopting new resources may be helpful to teachers, it is important for technology leaders to provide governance to district staff on how to protect student data and help prevent cyber incidents. More resources and best practices around data privacy and cyber security need to be available and accessible (not technology heavy vocabulary) for the school community as a whole. CoSN has published several documents related to both topics but will need to stay vigilant as the technology continually changes.
